



ANNUAL AWARDS

The OAMSS Board of Directors may present either or both annual awards at the business meeting at the OAMSS Fall Forum.

1. Only current active OAMSS members may submit a nomination for an award, self-nomination is permitted.
2. Current Board of Directors members are not eligible.
3. A nomination form will be posted on the OAMSS website and emailed to all current members.
General Nomination Criteria:
 - Nominee must hold either or both an active and in good standing the CPCS or CPMSM, with no ethics violations.
 - Nominee must be a current OAMSS member in good standing.
 - The nominator will submit the nomination form and a narrative (not to exceed 500 words) that includes a description of how the nominee meets the award criteria.
4. Nomination forms will be due no later than August 1st.
5. When submitted the nominations become the property of OAMSS and will not be returned. OAMSS reserves the right to reprint the nomination and any photographs on the OAMSS website.
6. It is the responsibility of the nominator to ensure the application is completed and submitted before the deadline.
7. The current OAMSS Board of Directors will evaluate all nominations. The current OAMSS Board of Directors will determine if either or both awards will be presented. Two-thirds (2/3's) majority approval of the Board of Directors is required.
8. The current OAMSS President will notify the immediate supervisor of the nominee who will be award recipient and ask for their cooperation in having the nominee attend the OAMSS Fall Forum.
9. The current OAMSS President will order/purchase the award and/or plaque for the award.

OAMSS Advocate Award

The Outstanding OAMSS Advocate Award recognizes professionals who have demonstrated a strong commitment to OAMSS through their contributions to the profession and OAMSS at the local, state and/or national level.

OAMSS Professional Achievement Award

The OAMSS President's award recognizes professionals who have demonstrated a strong commitment to the medical staff services profession by mentoring, sharing knowledge, fostering education opportunities and encouraging growth of the medical staff services profession.

- ☞ Nominee will be judged upon the information provided on the application form and narrative prepared by the nominator.

Criteria OAMSS Advocate Award:

- ☞ Nominee must demonstrate a strong commitment to OAMSS through their contributions to the Medical Staff Services profession and OAMSS at the local, state and/or national level.

Criteria OAMSS Professional Achievement Award

- ☞ Nominee must demonstrate a strong commitment to the medical staff services profession by mentoring, sharing knowledge, fostering education opportunities and encouraging growth of the medical staff services profession.
